

# **October testing**

Juniors will be taking the ASVAB (Armed Services Vocational Aptitude Battery) on Tuesday, October 6, 2020. ASVAB is the military placement test but also measures student knowledge and ability in several areas. This has a career exploration section which gives students an opportunity to learn more about themselves and the world of work, to identify and explore potential goals, and develop a strategy to help get to those goals.

Sophomores will be taking the PreACT on October 8th This test is very similar to the ACT test but shorter in length. It tests on all four ACT test subjects: English, math, reading, and science. The results predict future success on the ACT test, provide current achievement as well as projected ACT scores (1-36) on the ACT test they take as juniors. Students may begin sharing their information with colleges and scholarship agencies. The interest inventory provides students with a personalized view of colleges and career alignments. Sophomores may study for the PreACT as they would for the ACT. Sophomores, you have an OnToCollege account where you can prepare for the PreACT test. Please see Mrs. Poland for more information.

# **College Tours**

The Juniors and Seniors attended the EducationQuest sponsored Virtual College Fair September 27-September 31. They had the opportunity to meet with over 90 colleges. The Virtual College Fair recordings will be available until December 1, 2020. There were also webinars covering applying to colleges, financial aid, choosing a major, and paying for college held. We encourage all seniors and juniors to tour colleges of their interest. This provides additional information to parents and students as students begin to decide where they wish to attend college. Remember, 2-year and 4-year colleges are important to visit.

# **ACT Test Dates**

# 2020/2021 TAX REQUEST RESOLUTION FOR SHERMAN COUNTY SCHOOL DISTRICT 82-0015

WHEREAS, public was given at least four days in advance of a Special Public Hearing called for the purpose of discussing and approving or modifying the District's Tax Requests for the 2020/2021 school fiscal year for the General Fund, Bond Fund, Special Building Fund, and Qualified Capital Purpose Undertaking Fund of Sherman School District 82-0015; and,

WHEREAS, such Special Public Hearing was held before the Board of Education (hereinafter "the Board") of Sherman School District 82-0015 (hereinafter "the District") at the time, date, and place announced in the notice published in a newspaper of general circulation, a copy of which notice and proof of publication of which is attached hereto as Exhibit A, all as required by law; and,

WHEREAS, the Board provided an opportunity to receive comment, information and evidence from persons in attendance at such Special Hearing; and,

WHEREAS, the total assessed value of the property differs from last year's total assessed value by <u>-4%</u>; the tax rate which would levy the same amount of property taxes as last year, when multiplied by the new total assessed value of property would be <u>\$ 0.906396</u> per \$100 of assessed value; the <u>Litchfield School District</u> proposes to adopt a property tax requests that will cause its tax rate to be <u>\$ 0.936655</u> per \$100 of assessed value.

WHEREAS, based on the proposed property tax request and changes in other revenue, the total operating budget of <u>Litchfield School District</u> will exceed last year's by <u>7 percent</u>.

WHEREAS, the Board, after having reviewed the District's Tax Requests for each said fund, and after public consideration of the matter, has determined that the Final Tax Requests as listed below are necessary in order to carry out the functions of the District, as determined by the Board for the 2020/2021 school fiscal year.

NOW BE IT THEREFORE RESOLVED that (1) the Tax Request for the General Fund should be, and hereby is set at \$2,333,333; (2) the Tax Request for the Bond Fund should be, and hereby is set \$0.00; (3) the Tax Request for the Special Building Fund should be, and hereby is set at \$50,505 and (4) the Tax Request for the Qualified Capital Purpose Undertaking Fund should be, and hereby is set at \$80,808.

The threshold for Free/Reduced is much lower than one would think, please think of this as helping the school and not as an unneeded subsidy.

Dear Parent/Guardian:

Children need healthy meals to learn. Litchfield Public School offers healthy meals every school day. Breakfast costs Adult \$2.15, HS \$1.70, Elem \$1.55, PreK \$1.55; lunch costs Adult \$3.55, HS \$2.80, Elem \$2.55, PreK \$1.80. Your children may qualify for free or reduced price meals. Reduced price is \$.30 for breakfast and \$.40 for lunch. If your child(ren) qualified for free or reduced price meals at the end of last school year, you must submit a new application by September 28<sup>th</sup>, 2020 in order to avoid an interruption in meal benefits.

This packet includes an application for free or reduced price meal benefits and a set of detailed instructions. Below are some common questions and answers to help you with the application process.

## 1. WHO CAN GET FREE OR REDUCED PRICE MEALS?

- All children in households receiving benefits from the Supplemental Nutrition Assistance Program (SNAP),
   Temporary Assistance for Needy Families (TANF) or the Food Distribution Program on Indian Reservations (FDPIR) are eligible for free meals.
- Foster children that are under the legal responsibility of a foster care agency or court are eligible for free meals.
- Children participating in their school's Head Start program are eligible for free meals.
- Children who meet the definition of homeless, runaway, or migrant are eligible for free meals.
- Children may receive free or reduced price meals if your household's income is within the limits on the Federal
  Income Eligibility Guidelines. Your children may qualify for free or reduced price meals if your household income falls
  at or below the limits on this chart.
- 2. HOW DO I KNOW IF MY CHILDREN QUALIFY AS HOMELESS, MIGRANT, OR RUNAWAY? Do the members of your household lack a permanent address? Are you staying together in a shelter, hotel, or other temporary housing arrangement? Does your family relocate on a seasonal basis? Are any children living with you who have chosen to leave their prior family or household? If you believe children in your household meet these descriptions and haven't been told your children will get free meals, please call or e-mail Litchfield Public School, danielle.mcauliff@litchfieldps.org.
- 3. DO I NEED TO FILL OUT AN APPLICATION FOR EACH CHILD? No. *Use one Free and Reduced Price School Meals Application for all students in your household.* We cannot approve an application that is not complete, so be sure to fill out all required information. Return the completed application to: **Litchfield Public School, 500 N Main, Litchfield Ne 68852, 308-446-2244**.
- 4. SHOULD I FILL OUT AN APPLICATION IF I RECEIVED A LETTER THIS SCHOOL YEAR SAYING MY CHILDREN ARE ALREADY APPROVED FOR FREE MEALS? No, but please read the letter you got carefully and follow the instructions. If any children in your household were missing from your eligibility notification, contact Litchfield Public School, 500 N Main, Litchfield, Ne 68852, 308-446-2244 immediately.
- 5. CAN I APPLY ONLINE? You are encouraged to complete an online application instead of a paper application if your school district makes this option available. The online application has the same requirements and will ask you for the same information as the paper application. Visit to begin or to learn more about the online application process.
